LIMITED WARRANTY

MAX USA CORP. ("MAX") warrants that this product will be free from defects in material and workmanship under normal use for a period of one (1) year from the date of original purchase at retail.

If this product should prove to be defective in material or workmanship within the warranty period, MAX will at its sole option repair it or replace any defective part or parts, without charge to you. Any replacement part provided will carry a warranty for the balance of the period of warranty applicable to the part it replaces. The following parts are considered normal wearing parts and are not under this warranty: Bumper, Driver Blades, Piston Ring, Seals and springs.

For an evaluation of whether a defect covered by this warranty exists, and to obtain warranty service, you must take the product to the retailer or dealer where it was purchased, or deliver the complete product, transportation prepaid, to a MAX authorized service center, together with proof of purchase.

WARRANTY EXCLUSIONS

This warranty does not cover defects or damages caused by or resulting from accident, misuse abuse, neglect improper maintenance, or normal wear and tear. This warranty is valid only if all instructions contained in the operational manual are followed with care. This warranty also does not apply where repairs have been made or attempted by anyone other than MAX and its authorized service centers; alterations have been made to the product using parts that do not meet Max specification, size or quality; or the products has used continuously despite partial failure.
